Hello Harpenden...



The Harpenden Society supports a new Neighbourhood Health Centre for Harpenden. What is a Neighbourhood Health Centre?

The Government's 10 year plan supports the launch of a neighbourhood health service, which will see pioneering teams, some based entirely under one roof, set up in local communities across the country, to dramatically improve access to the NHS. As part of the government's aim to shift care out of hospitals and into the community, they will free up overstrained hospitals from perpetual

firefighting so they can focus on delivering only the best, most cuttingedge and personalised care.

These neighbourhood health centres will provide easier, more convenient access to a full range of healthcare

services right on people's doorsteps stopping them from having to make lengthy trips to hospitals. Neighbourhood teams will include staff such as nurses, doctors, social care workers, pharmacists, health visitors, palliative care staff and paramedics. Community health workers and volunteers will play a pivotal role in these teams.

Does Harpenden 'deserve' a NHC?

Harpenden&District's current population of 44,000 will grow by at least 5000 based on the predicted occupation of 1300 new houses in North Harpenden. In addition, the probable new builds behind the Harpenden Road at Woollams and the Hemel Garden Community

add in approximately 12,000 new properties over the next 15 years.

It is vital that the supporting health infrastructure is put in place before these new builds are substantially completed.

The ideal population size of a NHC is 30-50,000. Around Harpenden, St Albans is

well served by the Urgent Care Hub and new diagnostic services. The Luton and Dunstable Hospital has excellent facilities for its area, and Hemel Hempstead has an Urgent Care Centre and evolving plans for a new Health Campus in the town centre.



A Harpenden NHC, based in the town, would provide good access for those living in Harpenden, Wheathampstead, Redbourn, and the surrounding villages,

What needs to happen for a Harpenden NHC to be achieved?

All these new housing developments require the developer(s) to pay substantial sums to support the expansion of the necessary infrastructure, including Health Services, to initially St Albans District Council. They then direct the monies to the Hertfordshire and West Essex Integrated Care Board.

The ICB has overall strategic responsibility for the planning of our health services. The current ICB's geographical boundaries are due to change in the next two years, with Hertfordshire likely to join Bedfordshire, Cambridge and Peterborough in a merged organisation.

Although the ICB response to the Cooters End Lane application states that the ICB 'proposes to allocate the monies to the Harpenden PCN practices, this is by no means a firm commitment. Indeed, in general, the monies from the levy on developers do not necessarily go to provide new GP facilities in the heart of the new housing estates, but may go into a 'pot' at the ICB ,where the health priorities of the whole ICB area are decided.

It is therefore vital that a strong case is put together to support the Harpenden NHC.

The Harpenden PCN and the NHC

All the Harpenden GP practices need more space to see patients and provide the best care available. Our practices now employ a wide range of health care professionals, all of whom would work much more efficiently in a single premises

Harpenden also needs an Urgent Care Hub, which would be staffed by emergency care specialist practitioners.

The Harpenden Society supports our primary care teams in wishing to get this project moving, and welcomes the commitment of our local Councillors and our MP,Victoria Collins.

Victoria Collins MP's address to the Harpenden Society public meeting Oct 16 2025

In front to a lively audience at the Katherine Warington School, Victoria outlined her activities over her first year in the House of Commons.

In summary, she is one of the 20 most active members in the House, and in just over a year, she and her small team have been involved in over 10,000 personal and political issues with residents and others. She has attended over 600 debates, questions and speeches in the House, and asked 4 questions of the Prime Minister, and held over 300 advice surgeries, meetings and other local visits

One small anecdote from her early days in the House was that she walked into a cupboard thinking it was the door to the ladies toilet! The key subjects she focussed on include social care (especially dementia and



mental health), special education needs, the cost of living and holding the Environmental Protection Agency/Water Companies to account for the appalling levels of raw sewage discharge into our river systems and streams.

As leader for the LibDems on Science, Innovation and Technology, she is a highly vocal campaigner for online safety, and is promoting ethical Al innovation, not least pushing for a standard for age for data consent, which is supported by Bernardo's and Mumsnet.

In answering questions from the audience, she was asked what influence, as the third party in the House, the LibDems had on the Government. No hesitation in her reply – plenty – soft influence through collaboration with all parties, and hard influence through membership of select committees,

parliamentary questions and through national media.

She was then asked where the LibDems are re Europe, and her answer was an unequivocal yes to entering a customs union with the EU, given the economic disaster that Brexit had always been expected to deliver. Moving on to the question of ID cards, she was generally supportive, but they should not be mandatory, and when asked about the move to unitary local authorities, she was concerned that the efficiencies might be difficult to achieve, and that we may lose the local connection between residents and the

decision makers.

On more local issues, she was asked why the Local Plan for St Albans was taking so long? In reply, when the LibDems came into power in 2022, there was no plan, as the previous Conservative prepared Plan had been rejected by the Planning Inspectors, with no attempt to revisit it. The new LibDem group had to start from scratch, and given the complexity of the issues of the plan, it was always going to be a lengthy process.

The concern now is that the Plan has been prepared in accordance with the former Government's targets, and there is now the likelihood that the Labour Government will specify a higher level of housebuilding.

In thanking Victoria for her address and her answers to questions, Jeff Phillips, the chair of the Society, quoted from a Hansard booklet of advice to new MPs – 'you'll never get any thanks.....' – a quote that Victoria recalled reading!

Lawyer Mayor weighs Town Council's changing future role

When it comes to navigating her way around the legal as well as the administrative niceties of local government, Harpenden's new Town Mayor Cllr Beth Fisher, who took office in May, is eminently well qualified. She has been a lawyer for 25 years and is a member of the Bar Council, the recognised 'voice of the barrister profession in England and Wales.'

As an aside, her husband Richard is also a lawyer, a KC no less. And, perhaps appropriately, they were married in the chapel of

Lincoln's Inn – one of London's four historic Inns of Court. It is nevertheless perhaps too soon to determine whether their 15-year-old twin daughters and 13year-old son might follow in their parents' unimpeachable legal footsteps.

Beth – definitely not an abbreviation of Elizabeth, she is keen to point out – has been a Harpenden resident for 17 years,

following a 10 year barrister 'tenancy' in Cambridge. As one of the majority Liberal Democrat members of the Town Council she represents North Harpenden ward. She took over the mayoralty from her fellow Lib Dem councillor Pip Liver, who was profiled in these pages in our Summer 2024 newsletter.

One of the hot topics on all local council agendas is the mooted restructuring of local government which would mean, for Hertfordshire, the establishment of just one, or even up to five, so-called 'unitary authorities', largely supplanting the powers currently held by Herts County Council and – for the Harpenden area – St Albans District Council.

As Beth Fisher points out, the role of Harpenden Town Council would inevitably be affected if such a major county-wide administrative change, from a three-level to a two-level structure, were implemented. Whether the effect would be beneficial or otherwise for Harpenden's council tax payers is obviously a matter of paramount concern to our elected town councillors.

Accordingly an HTC working party has been established, to discuss the pros and cons of such a radical local government shake-up, especially the possibility for example, of the Town Council taking over, from a disbanded SADC, the 'ownership' of assets in the Town; a notable example being the Eric Morecambe Centre in Rothamsted Park (the ownership of the park itself having been successfully transferred some three years ago).

As ever in these matters the devil will be in the

financial detail, with vital questions surrounding the Town Council's post-reorganisation budget allocation from one upper-tier authority. Squeezed council budgets are, in 2025, the norm and the new mayor concedes that HTC's existing financial constraints have regrettably delayed a number of civic projects. including the proposed new sport pavilion development in



Rothamsted Park.

Mention should also be made of the 2025/26 Town Mayor's nominated charities: the Kings Pantry Food Bank, run by volunteers in collaboration with the Bethany Church and the Harpenden branch of the Salvation Army; and the Hertfordshire Domestic Abuse Helpline, which supports direct or indirect victims of domestic abuse.

When Beth Fisher is not concerning herself with Town Council affairs, she endeavours to maintain her physical wellbeing as a keen golfer and an enthusiast for Padel, which, for those unfamiliar with what is a relatively new sport, is effectively a cross between tennis and squash. Meanwhile regular dog-walking and her Peleton exercise bike are there to ensure that, closer to home, her fitness for her demanding mayoral role is not neglected!

A more unexpected leisure activity of the new mayor which she is apt to downplay is that of a now fully-qualified helicopter pilot, enabling her to appreciate the widely-acknowledged attractions of Harpenden as a thriving county town from what is surely a unique perspective.


Ron's Autumn Retail Round-Up

Eight Things You May Not Know About Luton Airport

The Harpenden Society has long campaigned—alongside organisations such as LADACAN—against the proposed expansion of Luton Airport. While that process continues, we thought it might be helpful to step back and share some key facts and background information.

Here are eight things you may not know about Luton Airport:

Runway Orientation

Luton Airport's single runway runs east-west, with around 70% of aircraft taking off westward toward Slip End.

Flight Routes

Westerly departures use three routes:

- 25 Olney (west then north)
- · 25 Rodni (west)
- 25 Match (south then east, serving most flights to central and northern Europe). The corridor passes west and south of Harpenden; aircraft should remain within it until crossing the railway line at 4,000 feet. However, deviations occur due to weather, congestion, or pilot error.

Local Benefits

The Society recognises that many Harpenden residents appreciate the convenience of nearby air travel. However, unlike Luton residents—who receive discounts on rail travel—Harpenden residents always pay full fares.

Airspace Conflicts

Efforts to establish a new westbound route avoiding Harpenden failed due to conflicts with Heathrow and Northolt flight paths. In March 2025, UK airspace management—including proposals to redesign routes—has passed to UK Airspace Design Service (UKADS), which is not expected to become fully operational until January 2026

Noise Management

The airport incentivizes the use of quieter aircraft such as the Airbus A320neo and Boeing 737 MAX, while charging higher fees for noisier models which do result in contravention of legal limits

Noise Surveys

Harpenden has been the subject of two previous noise surveys—automated (Oct–Dec 2017) and manual (May–July 2023)—with a third underway (July–Sept 2025).

Environmental Mitigation

The airport operators claim that expansion impacts will be offset through new technology and

mitigation measures. LADACAN disputes these claims, arguing that:

- Tree planting does not meaningfully offset carbon emissions.
- Sustainable Aviation Fuel (SAF) is impractical at large scale.
- Electric and hydrogen aircraft are not viable in the near term.

Submitting Complaints

The airport is required to respond to complaints about aircraft noise. To report one, email noise@ltn.aero, including the date, time, location, and a short description of how the noise affected you.

Be aware that repeated, identical complaints from the same few residents may be considered vexatious and ignored.

Technology can help: free websites and apps such as Travis LTN allow you to identify specific aircraft responsible for disturbance.



The Harpenden Society believes that Luton Airport is a valuable local asset which brings employment to the area and convenience for travelers. However, because of the environmental impacts and stresses it places on local roads we have consistently campaigned—alongside groups such as LADACAN—against its expansion.

At the time of writing, LADACAN is pursuing a judicial review against the Secretary of State, challenging the process by which approval for expansion was granted.

Eric Midwinter

Eric Midwinter, who sadly passed away last month aged 93, was an enthusiastic member of the Harpenden Society and was for many years, up until 2016, editor of the Society's quarterly newsletter. On the wider stage

he was a co-founder in 1980 of what was declared to be the University of the Third Age, a movement which soon came to be known simply as the U3A, with its Harpenden branch, under Eric's influence, one of the first to be formed and which thrives to this day.

Born at Sale, within the environs of Greater Manchester,

the son of a fireman, he became a working class grammar school boy, destined to make his mark in the world of academia. Eric and his wife Margaret were long-time Harpenden residents and members of the Harpenden Society whose quarterly newsletter he edited until 2016.

He described himself as an author, educationalist, gerontologist and social historian, with a specialisms in Victorian social history, sport and light entertainment. Both football and cricket were among his abiding interests, the latter receiving arguably disproportionate attention in his lengthy obituary in the Times, which made reference to his 1981 biography of WG Grace. He once wrote 'that if the Church of England is the Conservative

Party at prayer, cricket is the Church of England at play'.

Under the 'light entertainment' heading Eric was an acknowledged authority on the history of the Music

Hall, notably across the North of England, from Victorian times onwards. Among the 50 or so books he wrote were profiles of famous comedians. among whom he counted Ken Dodd as a particular friend, visiting him at his home in Knotty Ash, on the outskirts of Liverpool.



It is hard to

identify a talent he lacked. One however was that of never being a driver. 'I've never sat behind a steering wheel' he proclaimed unapologetically to someone who picked him up from his home in Bloomfield Road to attend a U3A meeting at the other end of Harpenden.

Eric's career landmarks include those of: Doctor of Philosophy and Lifetime Scholar of St Catharine's College, Cambridge; Director of the Liverpool Educational Priority Area Project; Head of the National Consumer Council's Public Affairs Unit; Director of the Centre for Policy on Ageing; Chairman of the Open University's Health and Social Welfare Board.
